As the learning of <u>foreign languages at the primary level</u> and <u>Asian languages at all levels</u> is not provided by schools, you are responsible for your child's tuition and must provide evidence to the school that he/she is receiving instruction from a private tutor/centre. Such evidence may be in the form of a letter from the tutor/centre or yourself.
